# **Call for selection of the DTT Project Manager**

DTT S.c. a r.l. is a consortium company for the construction of the Divertor Tokamak Test Facility at the ENEA laboratories in Frascati. DTT is an experimental plant for the development of fusion energy. The indicative resources for the construction are EUR 600 million. The start of the experimental activity is expected in the first half of 2028.

The Project Manager is accountable for his work to the Administrative Body which assigns him operational delegations and powers.

#### The Project Manager:

- ensures the execution of the DTT Project and guarantees the planning (both in terms of time scheduling and financial resources), execution (in the engineering, procurement and construction phases), monitoring, control and reporting of the Project in agreement with the objectives specified in the activity plan approved by the Board of Directors and by the Shareholders' Meeting;
- holds the role of Datore di Lavoro pursuant to Legislative Decree 81/08;
- can hold the role of Responsabile Unico del Procedimento (RUP) for contracts of particular importance and that of Responsible of Agreements with Shareholders and Third Parties:
- is delegated for the signing of deeds involving expenses up to a limit of € 1 million, regardless of type.
  The Purchasing, Legal, Project Service & Risk Management, Construction, HSEQ, ICT & General
  Services Functions report to the PM. The Managers of all Work Packages related to the construction
  of the plant (Hall, Additional Heating and Balance of Plant) and the System Integration Manager also
  report to the PM.

A master degree or old system Italian Laurea in Engineering, Physics, Chemistry or Mathematics is required. Experience of not less than 15 years in the field of Project Management is required, of which at least 5 in management roles on complex projects, preferably of an international nature, which mobilize resources of not less than 250 M€. Knowledge and experience of the Italian procurement system (Codice degli appalti) is preferable.

The reference contractual agreement is that for Executives of companies producing goods and services.

The compensation is in the range € 100.000 - € 150.000, and will be negotiated with the winning candidate on the basis of his/her seniority and experience. The contract will have a term of 5 years.

The place of employment will be at the Company's headquarters in Via Enrico Fermi 45 - Frascati.
